Typically, during the first 10 years of saving/ vesting, the investment component is 70-75% of the total portfolio value. The returns/appreciation constitutes just 25-30%. Then why focus too much on returns?

Margin of safety or diversification doesn't mean lower returns. It can actually give optimum returns by reducing the overall risk. Follow proper asset allocation at all times.





SIP – Rupee Cost Averaging

For most investors, SIP (Rupee Cost Averagi 3) could be the simplest and most effective investment strategy for creating long term wealth.
